Title: AMEND BYLAWS – EYEBALL NETS

Date: November 30, 2025

Sponsor: Eric Johnson, 10th Area Director

Implementation Timeline: January 1, 2026

Impact on Club finances and budget provisions: None

Background: Currently, there are no provisions in the Bylaws for determining ownership and limits for nets during the annual Eyeball. This motion addresses that deficiency.

Summary: This motion proposes updates to two areas of the Bylaws. First, it amends Article VI, General Information, paragraph C, to clarify that all Eyeball-related net operations must be

authorized by the Club President. Second, it revises Article V, Club Operations, paragraph A.6., by expanding and reorganizing the rules governing all special nets—including Eyeball QRP nets—providing clearer definitions of allowable nets and strengthening alignment with the procedures outlined in the NCS Guide.

Discussion highlights: W8NET: Due to health, cannot use a mechanical CW key, only a keyboard. AA0HF: We will talk offline about an accommodation.

KB1XP: Are we planning to vote at this meeting? AA0HF: Yes. KB1XP asked why we are doing this. Would like to hold off the vote.

VE3CMB: It is not an unfair advantage, anyone is invited to attend eyeballs and these nets. Similarly, someone that travels makes more contacts, but it is not unfair. AA0HF – Nets that

K9GWS: This was rushed, and also is a level of detail that does not belong in bylaws, nets are under the purview of the president who can eliminate them. Also asked for a list of those who have achieved master degrees by using these nets.

W8NET: Like the thought that there is some controls and guidelines, such as to not allow 160SSB. AA0HF: It is up to the board if they wish to make it easier to get awards.

KE3HAY: this removes sovereignty from the eyeball host and redirects it to an event designed to generate revenue under the guise of “community.” It’s a guardrail intentionally placed to block the path to a Master’s degree—one that no one can clearly prove has ever benefited anyone in actually achieving the award.

AA1NA: These nets are fun, only conducted at eyeballs.

AA0HF: Appreciates frank and candid discussions, and everyone making their diverse positions clear.

W6PNY (next eyeball host) Planned eyeball has less nets so that there is time for people to meet and get to know one another.

Financial Statement Notes

Overview

The following notes provide a summary of the 3905-Century Club's financial activities for December 2025.

Awards Revenue

During December 2025, the club's awards revenue was notably above average, totaling \$447. A significant portion of this revenue, amounting to \$232, was contributed by Brain (AA1QW) through submitted awards.

Net Income

As a result of the increased awards revenue, the club achieved a net income of \$108 for the month. This improvement is attributed to the higher-than-normal awards income.

Year-to-Date Performance

Despite the positive results for January, the club's year-to-date financial position reflects a loss of \$1,053.

Membership Activity

In December 2025, three new members submitted their first paid awards, indicating ongoing participation and engagement with new members.
