

Election 2017

The General Election 2017 for Odd-Area Directors, DX Director and Vice President has concluded as of midnight Jan 15 CST. A big thanks to all who ran for office and to all who voted.

A total of 163 ballots were cast in General Election 2017.

163 ballots were cast on-line. None were cast via postal mail or on the nets. 1 was cast via email, but was voided because the voter voted for an Area Director for an area he didn't live in.

5 of the on-line ballots had no candidates selected. All of those voters were contacted via email and told they could cast another ballot. 1 failed to do so.

4 of the total of 163 ballots were disqualified because the voter voted twice. 1 ballot was a Webmaster test and was voided Leaving 152 valid ballots.

152 of the 152 cast a vote for Vice President.

3 of the 76 voters eligible to vote for an Area Director failed to cast a vote for AD, one in the 3rd area and 2 in the 5th area.

As mentioned above, a runoff election is required for the office of Vice President between Ginger Wonderling AB6YL and Bill Wallace K1YAG. The date for this runoff is determined by our Bylaws and voting will begin on Jan 26th and run thru Feb 7th. An announcement will be sent to our reflectors and placed on our website.

The voter turnout, while not what it could easily be based on net participation and reflector membership, was higher than several past odd-year elections. I think this is a good sign.

New Award Honors Club's 40th Year

On behalf of your Awards Committee, I am pleased to announce a special **Fortieth Anniversary Award**. This highly flexible mixed band/mode award has tie-ins to several of our existing awards but it is also an interesting departure from anything the Club has previously offered. It will become available on the Club's 40th birthday, **February 7**, 2017.

Like our other awards, you earn this one by making contacts on our nets. To be eligible you must have earned a 3905 Century Club 100-point certificate, and then you must make a minimum number of contacts in specified categories during the anniversary year. We'll cover the details below and, of course, the full requirements and rules are posted on the Club's website.

Once you have met the basic requirements, you have to make a decision. You can either immediately apply for the basic award or you can increase your point total by making additional contacts in some more diverse categories. It is up to you to decide how far you wish to go. Any member may submit one and only one application, whether it is the basic award or a higher level, so you must make the decision wisely.

Apply for the **Fortieth Anniversary Award** at any time after February 7, 2017, but please remember that only confirmed contacts made during the **Club's 40th anniversary year** (**February 7, 2017 0000Z through February 6, 2018 2359Z**) count toward the award. Everyone starts with a clean slate, newbies and old-timers alike, so nobody has an unfair advantage. The more nets you work and the more contacts you make, the more points you will earn.



The Nitty-Gritty

Award, you must complete 67 contacts with individual *operators* in specified categories, each with point values, resulting in a minimum of 155 points. The Basic Requirements incorporate the numbers "3", "9", "0", "5", and "40" in recognition of our Club's

a. (3) Contacts with DX stations in different DX entities, other than Canada, Alaska, and Hawaii - 5 points each.

40th Anniversary:

- b. (9) Contacts with club officers, other than Master's
 Degree holders and NCSs. Multiple officer credit for
 the same operator not allowed 5 points each.
- c. **(10)** Contacts with Master's degree holders **5 points** each.
- d. **(5)** Contacts with NCSs, but no more than one NCS contact in any calendar month **1 point each**.
- e. Forty (40) Contacts with operators in different US states and/or Canadian provinces and territories 1 point each.

Notice that in category "c", we use the number "10" instead of "0". This is because we could not figure out how to give credit for ZERO contacts with anyone. We thought about counting attendance in nets in which ZERO contacts are made due to the lousy propagation we have experienced lately, but that would be ridiculous. Onward and upward.

We have provided point multipliers for PSK, RTTY, CW, and 160 meter contacts in hopes of sparking some additional activity on lesser populated nets. The multipliers apply to the contact points listed for each contact category, and they are: PSK or RTTY: x2; CW: x3; 160M (all modes): x3. So, get that top band antenna up, dust off the old J-38, and get your digital mode software ready for action!

Contacts Must Be with Unique Operators

Please note our emphasis on making contacts with unique, individual *operators*. Unlike many of our other awards, you may use <u>one and only one</u> contact with any given *operator*, regardless of whether his or her call sign has changed or is modified by mobile or portable designations. For example, let us pretend that I change my call sign from WA4DMV to AE4NT during the anniversary year and you receive QSLs from me for each of the two call signs operating fixed, mobile, and portable. You may use *only one* of those six cards for the Fortieth Anniversary

Award in any single category where it fits.

If you are wondering about clubs and special events, these <u>may not</u> be used for the <u>Fortieth Anniversary Award</u>. For example, if I check in with a club and a special event, you can use only the contact with my personal call sign for the <u>Fortieth Anniversary Award</u>. Of course, you will still be able to use the club and special event contacts for other 3905 Century Club awards.

What about contacts with operators on state borders or tri-points? You can use the contact, but you must decide which single category to fit it into. Once you use it anywhere on the application, you cannot use that operator contact in another category.

Why did we do it this way? We want to promote contacts with as many people as possible, and we want to maintain a level playing field. Above all, we wanted the award to be both fun and challenging.

For those of you who wish to go beyond the basics to earn more points, there are many different ways to boost your total, including some huge bonuses for contacts with rare categories such as original charter signers and charter members. We cover this in the next section of this article.

The Sky's the Limit!

Many of us enjoy the competitive aspect of our hobby by chasing various levels of DXCC, WAS, WAZ and the like, along with participating in programs such as NPOTA and last year's ARRL Centennial celebration. In order to create an award that could provide a similar competitive flavor, as well as to challenge those of you who want to set and achieve personal goals, opportunities exist to continue earning points toward the **Fortieth Anniversary Award** during the Club's entire anniversary year.

Those who choose to continue beyond the basic award requirements can earn additional points as follows, with no limit:

- a. Repeat the requirements of **8e** in the basic requirements:
 - First 40 or more additional states, provinces or territories – 3 points each.
 - ii. Subsequent 40 or more additional states, provinces or territories 5 points each.
 - iii. Double points in each case if you work50 before repeating.
- b. Work mobiles 3 points each.
- c. Work YLs 5 points each.
- d. Work combos 10 points each.
- e. Work from Tri-Points 10 points each; to Tri-

- Points 5 points each.
- f. Work from High Points 10 points each; to High Points 5 points each.
- g. Work additional Master's degree holders beyond the first 10 **5 points each.**
- h. Work an Original Charter Signer 100 points each.
- i. Work a Charter Member 50 points each.

Once your application is approved by your Area Award Manager, you will receive a certificate displaying the total number of points you earned. An updated listing of point totals, like a leader board, will be updated periodically and will be published on the Club website.

All contacts you apply to the **Fortieth Anniversary Award** may be used for other 3905 Century Club awards, assuming that they meet the other awards' requirements. For example, if you work several stations from a Tri-Point, those QSL cards you receive confirming those contacts may be used for both the Tri-Point and this award. The use of Master's contacts for this award will not invalidate your use of those contacts as Super Wild Cards in progressive and other awards where they are allowed.

Have It Your Way!

You now see how you can tailor this award to fit your needs. Apply whenever you want after you have met the basic requirements, and then keep an eye on the Club website to see how your point total stacks up against other members. As you plan your strategy, please remember these five key points:

- 1. Any member may submit one and only one application (lifetime).
- All contacts must be made on club nets during the 40th Anniversary Year (February 7, 2017 – February 6, 2018).
- 3. A contact with any individual <u>operator</u> may be used as <u>exactly one</u> contact.
- 4. For Club Officer contacts, multiple office holders count as **exactly one** officer contact.
- 5. Apply at any time after February 7, 2017, once the basic requirements are met. There is no ending time limit.

We hope you will have a lot of fun working toward the Fortieth Anniversary Award! Happy New Year to you and yours and we'll see you on the nets!



The Radio Spectrum Processor Ver2 (RSP2)

From SDR Play

The **SDR Play RSP2** is a small box about 3" X 3" and about an inch deep. It is a good performing all mode communications receiver that covers from 1 KHz to 2 GHz with no gaps in coverage.



Generally, receivers in this price category fall short in dynamic range (ability to copy weak signals in the presence of strong ones), front end overload, and interference from signals on adjacent frequencies. This one does not.

The SDR Play has a 12 bit Analog to Digital converter (A/D). Compare this with the 8 bit A/D in the typical USB dongle receivers.

With 8 bit A/D you get a dynamic range of 256 levels. (the range from weakest to strongest signal). With 12 bit A/D, you get a dynamic range of 4,096 levels. That is a 12 dB performance increase ... with each 3 dB being a doubling of dynamic range.

Where I think this manifests itself is listening in to the crowded 80 meter band in the evenings. Even with two or more stations within the same filter bandpass, I can copy the desired station almost as good as I can with my Flex. Listening to standard AM

and shortwave broadcast stations is also a treat. There still is a lot of music being transmitted by both of these services and between the increased dynamic range and the ability to increase the bandwidth of the receiver, sometimes the broadcast quality rivals that of commercial FM (in my opinion anyway).

It has two 50 ohm **SMA** antenna ports and a high impedance antenna port (all selectable from the main screen). The 50 ohm ports are limited to 1.5 MHz to 2 GHz. The high impedance port, designed for open wire feeders, covers from 1 KHz to 2 GHz. This could also be used with 50 ohm unbalanced coax with or without a balun.


The **RSP2** is powered by USB and comes with an incredible software suite called "SDR Uno". With this software, you can display up to a 10 MHz wide swath of frequencies that are in the 1 KHz to 2 GHz coverage of the receiver. Think about it ... you can look at the entire AM broadcast band the entire 160 meter band, all of 80 meters, all of 40 meters, and all of 60 meters ... spread out "for your viewing pleasure" across one screen (see top of previous page)! Running windows XP and a dual processor, I'm limited to about a 4 MHz swath. Using Windows 7 with a quad core 15 processor, I can easily get the entire 10 MHz swath.

This receiver will receive AM, FM, CW, SSB and much more. Under each of these modes there are options. Under "AM" is regular "AM" or synchronous AM. The latter is used with some international short wave stations to improve coverage. Using "FM", you get various band widths that covers everything from wide band broadcast FM to the 5 KHz deviation that we use on our repeaters.

Another area where the SDR Play really shines is in the reception of images from the NOAA weather satellites on 137 MHz. These are in low earth orbit and are above the horizon for a maximum of about 20 minutes during each pass. These satellites don't send down a complete image. Rather they scan one line at a time as they continue on their orbit. You receive

each of these lines and build up the complete image in your computer. After a typical pass, you will end up with a nice high resolution image from down slightly below Cuba ending up into Canada.

The nice thing about this receiver is that you can tailor the RF passband to exactly optimize image reception. Right now **Ryan Duke, KC3FSJ**, **Jeff Patterson, KB3RCT** and I are enjoying this capability.

The receiving unit itself also has interface connections that allow the referencing to a high precision 10 MHz oscillator or GPS. There is also an output that allows the referencing of several **SDR Play receivers** with each other ...

Remember, this is a \$169 receiver!!!


Rather than have you read more about this really cool receiver here, I suggest that you log on to YouTube and do a search on "SDR Play".

You will find many demonstrations with actual reception of signals off the air. You will be impressed!

- * Monitor any Amateur frequency up through 1.2 GHz and beyond, any mode.
- * Just listening to AM Broadcast Radio ... you'll think that you're listening to FM ... and there's still good programming on AM.
- * AM Broadcast DXing ... this receiver coupled with an E- Field probe antenna is amazing! One of the stations that I listen to almost every evening is AM740 out of Toronto Canada. Zoomer Radio ... Great Oldies!!
- * Covers all of the international shortwave bands with fidelity second to none.
- * Decode JT65, JT9, PSK31, SSTV, and any other digital mode using free communications software (MMSSTV, FLDIGI, etc)
- * Monitor CB (if you want) and absolutely all existing analog public service frequencies.
- * Interface with widely available (free) API's to decode and listen to virtually all of the digital voice modes (P25, DMR, Fusion, etc)

- * Listen to Family Radio System (FRS) HT's and GMRS. Listen to the folks at the drive thru at McDonalds or what's happening at WalMart ... did they catch that shop lifter?
- * Interested in Radio Astronomy? This would make a great receiver for an Amateur Radio Telescope capable of receiving the Hydrogen Line on 1420 MHz.
- * Explore the radio spectrum ... there's a lot out there and this radio covers most of it!

Finally, check out the image below. This was a direct reception of NOAA 15.

HISTORY OF THE CAR RADIO

Seems like cars have always had radios, but they didn't.

Here's the story:

One evening, in 1929, two young men named William Lear and Elmer Wavering drove their girlfriends to a lookout point high above the Mississippi River town of Quincy, Illinois, to watch the sunset. It was a romantic night to be sure, but one of the women observed that it would be even nicer if they could listen to music in the car. Lear and Wavering liked the idea. Both men had tinkered with radios (Lear served as a radio operator in the U.S. Navy during World War I) and it wasn't long before they were taking apart a home radio and trying to get it to work in a car. But it wasn't easy: automobiles have ignition switches, generators, spark plugs, and other electrical equipment that generate noisy static interference, making it nearly impossible to

listen to the radio when the engine was running. One by one, Lear and Wavering identified and eliminated each source of electrical interference. When they finally got their radio to work, they took it to a radio convention in Chicago. There they met Paul Galvin, owner of Galvin Manufacturing Corporation. He made a product called a "battery eliminator", a device that allowed battery -powered radios to run on household AC current. But as more homes were wired for electricity, more radio manufacturers made AC-powered radios. Galvin needed

a new product to manufacture. When he met Lear and Wavering at the radio convention, he found it. He believed that mass-produced, affordable car radios had the potential to become a huge business.

Lear and Wavering set up shop in Galvin's factory, and when they perfected their first radio, they installed it in his Studebaker. Then Galvin went to a local banker to apply for a loan. Thinking it might sweeten the deal, he had his men install a radio in the banker's Packard. Good idea, but it didn't work – Half an hour after the installation, the banker's Packard caught on fire. (They didn't get the loan.) Galvin didn't give up. He drove his Studebaker nearly 800 miles to Atlantic City to show off the radio at the 1930 Radio Manufacturers Association convention. Too broke to afford a booth, he parked the car outside the convention hall and cranked up the radio so that passing conventioneers could hear it. That idea worked – He got enough orders to put the radio into production.

WHAT'S IN A NAME

That first production model was called the 5T71. Galvin decided he needed to come up with something a little catchier. In those days many companies in the phonograph and radio businesses used the suffix "ola" for their names - Radiola, Columbiola, and Victrola were three of the biggest. Galvin decided to do the same thing, and since his radio was intended for use in a motor vehicle, he decided to call it the Motorola. But even with the name change, the radio still had problems: When Motorola went on sale in 1930, it cost about \$110 uninstalled, at a time when you could buy a brand-new car for \$650, and the country was sliding into the Great Depression. (By that measure, a radio for a

new car would cost about \$3,000 today.) In 1930, it took two men several days to put in a car radio -- The dashboard had to be taken apart so that the receiver and a single speaker could be installed, and the ceiling had to be cut open to install the antenna. These early radios ran on their own batteries, not on the car battery, so holes had to be cut into the floorboard to accommodate them. The installation manual had eight complete diagrams and 28 pages of instructions. Selling complicated car radios that cost 20 percent of the price of a brand-new car wouldn't have been easy in the best of times, let alone during the Great Depression - Galvin lost money in 1930 and struggled for a couple of years after that. But things picked up in 1933 when Ford began offering Motorola's pre -installed at the factory. In 1934 they got another boost when Galvin struck a deal with B.F. Goodrich tire company to sell and install them in its chain of tire stores. By then the price of the radio, with installation included, had dropped to \$55. The Motorola car radio was off and running. (The name of the

company would be officially changed from Galvin Manufacturing to "Motorola" in 1947.) In the meantime, Galvin continued to develop new uses for car radios. In 1936, the same year that it introduced push-button tuning, it also introduced the Motorola Police Cruiser, a standard car radio that was factory preset to a single frequency to pick up police broadcasts. In 1940 he developed the first handheld twoway radio — The Handy-Talkie — for the U. S. Army. A lot of the communications technologies that we take for granted today were born in Motorola

labs in the years that followed World War II. In 1947 they came out with the first television for under \$200. In 1956 the company introduced the world's first pager; in 1969 came the radio and television equipment that was used to televise Neil Armstrong's first steps on the Moon. In 1973 it invented the world's first handheld cellular phone. Today Motorola is one of the largest cell phone manufacturers in the world. And it all started with the car radio.

WHATEVER HAPPENED TO

the two men who installed the first radio in Paul Galvin's car? Elmer Wavering and William Lear, ended up taking very different paths in life. Wavering stayed with Motorola. In the 1950's he helped change the automobile experience again when he developed the first automotive alternator, replacing inefficient and unreliable generators. The invention lead to such luxuries as power windows, power seats, and, eventually, airconditioning.

Lear also continued inventing. He holds more than 150 patents. Remember eight-track tape players? Lear invented that. But what he's really famous for are his contributions to the field of aviation. He invented radio direction finders for planes, aided in the invention of the autopilot, designed the first fully automatic aircraft landing system, and in 1963 introduced his most famous invention of all, the Lear Jet, the world's first mass-produced, affordable business jet. (Not bad for a guy who dropped out of school after the eighth grade.) Sometimes it is fun to find out how some of the many things that we take for granted actually came into being! AND It all started with a woman's suggestion!

Acting Chairman Marty, AG5T: D&O and Liability Insurance. Motion is **11_2016_03**. We had tabled it and need a motion to bring it back on the board. Moved by Buddy W3BS, Second by Joe N5MIG.

Discussion:

Rocco, WU2M "Correct me if I am wrong but we are protected because we are incorporated? A person can sue the corporation NOT the individual"?

Joe, N5MIG: "No being incorporated has no bearing on being sued. We can be sued as a corporation or as an individual".

Bill, K6YEK: "The Club can be sued for anything. The directors and officers may also be named as well. Incorporation does not protect the D&O's as there is also a concept of piercing the corporate veil. This can occur through some very innocent actions taken by the Club. That is one of the reasons for the D&O insurance".

Acting Chairman Marty, AG5T: "Ok, I want to be clear. A yes vote on this is saying you believe we need the insurance and a no vote is saying it is not needed at this time. Want to make sure I get it right."

Peter, N2XTT: "So if we won't let two people check in as combo we can be sued, if they are legally married and not husband and wife."

Ralph, KG8WL: "Florida law allows discrimination for non-profit's."

Rocco, WU2M: "Not according to our combo definition."

Peter, N2XTT: "Not according to the way our combo reads."
