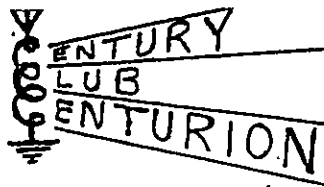

"EYE-BALL FIVE - EAST" by WD4CQY

During their regular February meeting, the Board of Directors voted to hold "Eye-Ball FIVE - East" at Dogpatch USA, near Harrison, AR, on August 13th through 15th. Rock Candy Mountain Campground adjoins Dogpatch. (Information on any "Eye-Ball FIVE - West" was not available at press time.)

Letha, KA5HFB, has agreed to act as on-site coordinator, and she has sent the "Centurion" road-routing recommendations as follows:

Dogpatch, USA, and Rock Candy Mountain Campground are located on Arkansas State Highway 7, about 8 miles south of Harrison, AR.

FROM NORTH OF THE OHIO RIVER AND EAST OF THE MISSISSIPPI RIVER - Via Saint Louis, MO, I-44 to Springfield, MO, south on U.S. 65 to U.S. 62, then southwest to Ark. 7, south to Dogpatch;

FROM THE EASTERN U.S. AND THE SOUTHEAST - Via Memphis, TN, I-40 through Little Rock, AR, to Russellville, AR, then north on Ark. 7 to Dogpatch;

FROM THE WEST AND SOUTHWEST - Via Fort Smith, AR, I-40 to Russellville, AR, then north on Ark. 7 to Dogpatch;

FROM THE NORTH AND NORTHWEST - Via Springfield, MO, south on U.S. 65 to U.S. 62, southwest on U.S. 62 to Ark. 7, then south to Dogpatch.

(Editor's Note: Dogpatch, USA, is located roughly equidistant from Springfield, MO, Little Rock, AR, and Fort Smith, AR. For those attendees who might wish to fly to the "Eye-Ball", airlines flying the most flights (or ONLY flights) into these three cities are: Little Rock - Delta Airlines; Springfield - Ozark Airlines; Fort Smith - Scheduled Skyways (a commuter airline out of Saint Louis, MO.) I am told that rental cars are available at each of the above airports.)

Letha points out that there are a number of scenic areas in the vicinity of Harrison; in fact, Arkansas Highway 7 is, itself, a very scenic route.

She says that the area is particularly radio-noise-free and she has almost complete copy on the Century Club nets, from coast to coast.

She promises to "take a run over to Harrison", once the weather improves, to check out the repeaters. (Perhaps we'll have repeater frequencies, in the June issue.) She already has gotten an invitation, from the Harrison Repeater people, for the Club to use their repeater as much as we need. As mentioned, when winter is gone, she'll trek over, but, since Letha lives over 100 miles from Dogpatch, it's not quite like just running up to the top of the next hill to check them.

There are, among others, a Ramada Inn and a Holiday Inn, in Harrison, for those not planning to camp. For further information on any of the above, send a business-size SASE to:

WHERE DOES IT SAY THAT ... by WA2ZYM

(Editors Note: This is a re-write of Bill's column, from his memory. His ORIGINAL SUBMISSION has been in the mail 18 days, now, and HAS NOT YET BEEN RECEIVED.)

As you who read last month's column will know, one of the main topics was the recent update of the By-Laws, and the effect of that update on the awards program. It was noted that the revised By-Laws were available from the Club Secretary, Marianne, W3LQY, whose address appears elsewhere in this issue.

Why mention this again? Well, it seems that some people just don't get the word. The changes that took effect were really massive in scope, and everyone should have the latest rules. This month,

we will review some of the changes and some of the effects on your search for the various awards.

The most wide, sweeping change is with respect to the use of QSL cards. Previously, if you used a card once, you could not use it again. Now, with the revision, you may do so in most cases. Perhaps the easiest way to show these changes is to use a hypothetical QSO and show how that card may be used.

Assume that you work me, WA2ZYM, at my home QTH. Under the revised rules, you may still only use me one time, on the 100-500-1000 progression. If you use me as a prefix, on the 500, you may use me again as a certificate holder, on the 1000, BUT ONLY IF YOU WORK ME A SECOND TIME.

But, again, under the revised rules, you may use the original card on the Poker Player, Baker's Dozen, Night Owl (if it was a Late Net contact), on the WAS endorsement, Journeyman, etc. ALL WITH THE SAME CARD, FROM THE SAME CONTACT. This is a major change, of which most people still are not aware, since there still are numerous questions on the Q & A sessions about it.

REMEMBER: If the award for which you are working does not fall within the 100-500-1000 category, THERE IS NO LONGER ANY LIMIT ON HOW MANY TIMES YOU USE THE ONE (SAME) CARD.

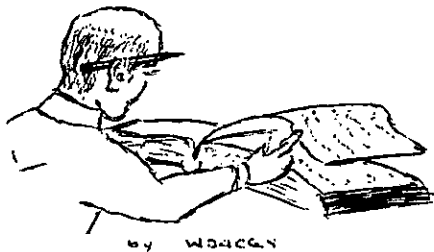
By the time this reaches you, the application sheets for the DX Award should be available. This is a tough one, requiring 25 different countries, with endorsements for each 5 extra countries up to 100. One important rule about this award is that the 48 contiguous states, and Alaska and Hawaii DO NOT COUNT AS DX. Other than this, you may count any country that is on the ARRL Country List, in the back of your log. But, that country MUST have operating privileges in the part of the band where the Club operates. Once again, you may use cards that you have used on other awards.

To close out this month's column, I would like to suggest that if you don't have a copy of the By-Laws, by all means, get one. If you are an NCS, then you should, shortly, receive a package from your NCS Coordinator, with the new NCS Guide, preamble, By-Laws, Certificate Holders List, etc., that are essential for you to do a good job.

I will close by reminding you all, again, that if you have any questions, please get them to me. I will do my best to answer them. In fact, I will answer your letters by return mail, then print the Q & A in the column. This way you won't have to wait 3 months for the answer.

BE PREPARED TO QSL OR DON'T QSO - Editorial by WD4CQY

Three weeks ago, the 3905 Century Club celebrated its Fifth Anniversary. I seriously doubt that any of its founders, even in their wildest dreams, ever thought that the Club would have the success, or gain the stature, that it can now claim.

The growth in membership has been very nearly phenomenal; the manner in which the "New Blood" has stepped forward to fill the breach when members of the "Old Guard" left, has been most heartening. The interest shown by numerous members who have written needed, and hard-to-get stations, to invite them on the nets, is commendable.

However, even as the Club has grown in size and maturity, the percentage of "come-back QSLs" has steadily DECLINED. There have been those who have accused the Club QSL Bureaus of "droppong the ball", but, friends, if the Bureaus don't get 'em, they can't send 'em. (In January, I received a bureau shipment that contained a return QSL for a net QSO in May, 1980. The card said, "Thanks for your call". This sort of delay is unconsciounable and unacceptable, unless there is a valid reason - AND that valid reason should be written on the card.)

The Club By-Laws provide for the withdrawal of membership from anyone who consistently fails to QSL - and, boys and girls, we do have a few like that.

Not everyone uses the bureaus, so you may have to go direct. There are times that someone may be out of cards. Those are both valid excuses for delay in QSLing; but, if you know of someone who simply refuses to QSL, let your Director know.

BULK-RATE MAILING PERMIT, YET AGAIN...Editorial, by WD4CQY

I have a friend of very long standing who is one of three brothers, all of them from Nebraska where his parents still live. The first time I met the father, in a quiet moment he showed me a snapshot of his three sons, and pointing to the eldest, he said "He was an innocent experiment"; he pointed to the middle son and said "He was misplaced confidence"; and, to the youngest, "He was just damn foolishness".

Most readers will be aware that there was a protracted delay in collecting the necessary documents for filing for IRS tax-exempt status and for a bulk-rate mailing permit; but, finally, last October the IRS application was filed; and, on the first business day of January, 1982, the USPS application was filed.

I won't go into all the yo-yoing of the IRS application. Suffice it to say that it was necessary for me, in rebuttal, to copiously quote both FCC Regulations and Webster's Dictionary, in order to prove to the IRS that the 3905 Century Club was a "hobby" and "social" club. The un-mucilaged stamp had not yet fallen off that mailing when I heard from the local postmaster that the bulk mail commissar, in Miami, had turned down our bulk-rate application, BECAUSE "HOBBY CLUBS" WERE NOT QUALIFIED FOR SPECIAL BULK-RATE MAILING, according to the Postal Manual. Fortunately, an appeal was allowed; and, even more fortunately, a few days before, I'd received a "bulk-mailed" 12-pager from the Orlando Amateur Radio Club. An appeal was filed, of course.

Now, you may ask, what does the first story, above, have to do with the second? Let me tell you the way I see it!

When our national leaders pass a law relative to the Internal Revenue Service or the U.S. Postal Service, that is an "INNOCENT EXPERIMENT" (LARGE benefit of doubt.) When they allow the head bureaucrats in those two "services" to write and ENFORCE regulations, that is "MISPLACED CONFIDENCE". BUT, when the heads of those "services" put people on the Federal Business-End of a typewriter or a telephone, with little education and no indoctrination, EVEN IN THEIR OWN SPECIALTIES, I submit that that is "DAMN FOOLISHNESS".

FROM THE BOARD ROOM by WD4CQY

The Board, during its December meeting, validated the nominations of three members to stand for election to the office of Club President. The nominees were:

The January Board meeting, among other things, approved the SWL Award and its associated criteria.

- "Eye-Ball FIVE" to be held at Dogpatch, AR - Yes.
- We adopt a paper ballot for Presidential/Vice-Presidential elections - No.
- Hold separate paper ballot elections for President and Vice-President - No.
- We establish a net on 20 meters on Sat. or Sun. - No.
- We do something to support the CW nets - No vote necessary.
- Approve the making of two calls at one time - No vote necessary; provided for in the By-Laws.
- Get into the rules what constitutes a valid signal report - No vote necessary; defined in the By-Laws.
- Cut down on time taken on information at the beginning of the nets. No vote taken.
